Vintage Ozark Laundry Service does not intentionally store complete credit card numbers or sensitive payment credentials on our systems.

3. Website Information

When visiting our website, certain technical information may be collected automatically, including:

- Device Information
- Operating System
- Website Usage Information
- Date and Time of Visit

This information helps improve website performance, security, and customer experience.

4. How We use Your Information

Customer information may be used to:

We do not routinely photograph individual clothing items during normal service.

Documentation, when necessary, is limited to order verification, existing damage, unusual garment conditions, commercial account verification, or circumstances requiring communication with the customer.

Customer laundry contents remain confidential.

8. Data Security

Vintage Ozark Laundry Service takes reasonable administrative, physical, and technical measures to help protect customer information from unauthorized access, disclosure, alteration, or destruction.

While no electronic system can guarantee absolute security, we continuously strive to safeguard customer information using commercially reasonable practices.

9. Data Retention

Customer information is retained only for as long as reasonably necessary to:
